

About the Workshops

The **Lidcombe Program** is a behavioral intervention, developed to treat stuttering in preschool aged children. After training, speech-language pathologists will be prepared to teach parents to administer appropriate feedback about fluency and stuttering to their children in their everyday-speaking environment and to monitor treatment goals and progress. Studies have shown that this is an efficacious and effective evidence-based treatment for stuttering.

The Lidcombe Program has been adjusted for **school-aged children** and special populations. The second workshop will discuss those adjustments as well as other evidenced-based treatments. Participants will leave with customized treatment plans for children who stutter and who present with other speech language concerns.
